**RESOLUTION NO. 2024-64**

**"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN, ON BEHALF OF THE MUNICIPALITY OF SAN PABLO, TO EXECUTE AND SIGN A MUTUAL PARTNERSHIP AGREEMENT (MPA) WITH THE DSWD-FIELD OFFICE IX, ZAMBOANGA CITY, FOR THE OPERATION AND MAINTENANCE OF THE COMPLETED SUB-PROJECTS ON THE FOLLOWING SIX (6) BARANGAYS, NAMELY: CULASIAN, BUBUAL, KAPAMANOK, LUMBAYAO, POBLACION AND MARCOS VILLAGE AND ONE (1) ON-GOING CONSTRUCTION OF EVACUATION CENTER THAT COMPRISED THE TWENTY-TWO (22) CLUSTERED BARANGAYS, LOCATED AT BARANGAY POBLACION, TO ASSURE ITS SUSTAINABILITY, FOR PHASE-2 IMPLEMENTATION UNDER KALAH-CIDSS NCDDP-AF."**

**WHEREAS**, during its regular session, Mrs. Evelyn Tablate, KALAH-CIDSS-AF Coordinator of this municipality, personally appeared and requested this August Body to pass a resolution authorizing the Municipal Mayor to execute and sign a Mutual Partnership Agreement (MPA) with the DSWD-Field Office IX, Zamboanga City for the operation and maintenance of the completed and on-going projects to assure its sustainability, under Phase-2 implementation under KALAH-CIDSS NCDDP-AF;
