RESOLUTION NO. 2024-66

"A RESOLUTION ADOPTING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO 2024-4 OF SAN PABLO, ZAMBOANGA DEL SUR, AMOUNTING TWO MILLION TWO HUNDRED FIFTY-ONE THOUSAND ONE HUNDRED NINETEEN PESOS (P2,251,119)."

WHEREAS, Resolution No. 2024-4 of the Municipal Development Council (MDC) of San Pablo, Zamboanga del Sur, realigned the amount of Three Million Seven Hundred Twenty-Three Thousand Five Hundred Seventy-One Pesos and Forty-Eight Centavos (P3,723,571.48) from previous years balances in the Annual Investment Plan (AIP);

WHEREAS, out from the total amount, the August Body already approved the proposed construction of Canopy and fence item in the thru resolution no. 2024-56, dated July 17, 2024 with a total amount of One Million Four Hundred Sixty-Eight Thousand Four Hundred Fifty-Two Pesos (P1,468,452.00);

WHEREAS, the remaining balance of Two Million Two Hundred Fifty One Thousand One Hundred Nineteen Pesos (P2,252,119.00) shall be appropriated for the following:
