EXCERPT FROM THE MINUTES OF THE 77TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON JULY 17, 2024.

RESOLUTION NO. 2024-68

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE BDO FOUNDATION FOR THE RHU REHABILITATION PROGRAM."

WHEREAS, BDO Foundation is the Corporate Social Responsibility arm of BDO Unibank, that rehabilitates Rural Health Units (RHU's) in economically disadvantaged communities all over the country;

WHEREAS, the rehabilitation includes the following provisions:

1. General renovation and re-layout to create more space and allow more air and sunlight inside the RHU;
2. Re-design of the RHU to include the following components (if floor /lobby area permits)
 - Information area; play area for children (with books and toys); waiting lounge for the elderly; private breastfeeding station for nursing mothers.
3. Provisions of basic furniture and fixtures and window blinds
 - Installation of non-lighted façade signage, door signages and wall graphics
 - Repainting of Interior walls based on BDO's color-scheme
4. No horizontal or vertical room/area extension or expansion (Existing Floor area only)

WHEREAS, San Pablo Municipal Health Office (MHO) located in Barangay Poblacion, San Pablo, Zamboanga del Sur has been selected for renovation and interior fit-out works of BDO Foundation (BDOF) as per information received from the Program Support Officer of the BDO Foundation, Inc. in the person of Ederlyn Joy A. Horca.

WHEREAS, the Rehabilitation program is a donation from BDO Foundation in partnership with the LGU thru signing a Memorandum of Agreement;

WHEREFORE, on motion by Hon. Jorge R. Gonzales, severally seconded, be it

RESOLVED, as it is hereby resolved, **AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE BDO FOUNDATION FOR THE RHU REHABILITATION PROGRAM.**
