**RESOLUTION NO. 2024-78**

**"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN, TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) FOR THE IMPLEMENTATION OF DOLE INTEGRATED LIVELIHOOD PROJECT AND EMERGENCY EMPLOYMENT PROGRAM IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."**

**WHEREAS**, presented for consideration is a request for authority of the Municipal Mayor to enter into Memorandum of Agreement (MOA) for and in behalf of the Local Government Unit of San Pablo, Zamboanga del Sur, with the Department of Labor and Employment (DOLE) Region 9 relative to the implementation of the DOLE Integrated Livelihood and Emergency Employment Program (DILEEP);

**WHEREAS**, the program contributes to poverty reduction and reduce vulnerability to risks of the poor, vulnerable and marginalized workers either through transitional emergency employment and promotion of livelihood and entrepreneurship;

**WHEREAS**, section 444(b)(1)(vi) of the Local Government Code of 1991, a Municipal Mayor is required to secure the prior authorization of the Sangguniang Bayan before entering into contract in behalf of the municipality.

**WHEREFORE**, on motion by Hon. Andres M. Villanueva, III, severally seconded, be it
