## **RESOLUTION NO. 2025-09**

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DIVINE NELEH A. TAUCAN-ANGHAD TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF SAN PABLO, ZAMBOANGA DEL SUR, WITH MSU-IIT NATIONAL MULTI-PURPOSE COOPERATIVE, RELATIVE TO THE PROVISION OF PRODUCTS AND SERVICES, THAT MEET CONSTITUENTS' NEEDS, INCLUDING SAVINGS, CREDIT, AND OTHER BENEFITS."

**WHEREAS**, the Local Government Unit of San Pablo, Zamboanga del Sur, is committed to promoting the economic well-being and financial empowerment of its constituents;

**WHEREAS,** it is necessary to authorize the Municipal Mayor, Hon. Divine Neleh Taucan-Anghad to enter into a Memorandum of Agreement (MOA) with the MSU-IIT National Multi-purpose Cooperative to formalize this partnership.
