**RESOLUTION NO. 2025-10**

**"A RESOLUTION AUTHORIZING THE MUNICIPAL VICE MAYOR, ATTY. FLAVIO P. CORDERO, JR. AND THE MUNICIPAL TREASURER, MRS. DIONA W. WAMILDA AS THE OFFICIAL SIGNATORY OF THE LEGISLATIVE OFFICE IN THE GENERAL FUND ACCOUNT NO. 0522-1118-48 OF SAN PABLO, ZAMBOANGA DEL SUR IN ITS BANKING TRANSACTION AT LAND BANK OF THE PHILIPPINES (LBP) PAGADIAN BRANCH, PAGADIAN CITY."**

**WHEREFORE**, on motion by Hon. Dennis P. Cordero, severally seconded, be it


