## **RESOLUTION NO. 2025-11**

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DIVINE NELEH A. TAUCAN-ANGHAD TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE – REGIONAL OFFICE IX, FOR THE IMPLEMENTATION OF THE LIVESTOCK-BASED ECONOMIC ENTERPRISE DEVELOPMENT (LEED) PROGRAM – ESTABLISHMENT OF MULTIPLIER FARM FOR LGU SAN PABLO, ZAMBOANGA DEL SUR."
