RESOLUTION NO. 2025-143

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH (DOH) THRU JOSHUA M. BRILLANTES, MD, MPH, CESO IV, IN HIS CAPACITY AS THE DIRECTOR IV OF ZAMBOANGA PENINSULA CENTER FOR HEALTH (CHD), AND HEREIN REFERRED TO AS THE DOH, AND DR. JOAN MAE C. BUGAY WITH RESIDENCE AT ALORAN, MISAMIS OCCIDENTAL ASSIGNED IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR, AS PART OF THE DOH – DTTB, FOR THE DEPLOYMENT OF A RURAL HEALTH PHYSICIAN THRU THE "DOCTORS TO THE BARRIOS PROGRAM" TO THE MUNICIPALITY OF SAN PABLO, PROVINCE OF ZAMBOANGA DEL SUR."

WHEREAS, the municipality of San Pablo is in dire need of additional Physician, who will assist the LGU in improving its health services to the people, considering the increasing number of population in the recent survey;

WHEREAS, the Department of Health implements the Human Resource for Health (HRH) Deployment Program to promote access to quality health services to the marginalized, vulnerable and disadvantaged population of the country, thru the Doctors-to-the-Barrios (DTTB) Program to assist in the improvement of local public health system;

WHEREAS, the Local Government Unit of San Pablo requested the services of a "Doctor to the Barrios" to serve all the barangays to the municipality including the most inaccessible ones for the implementation of different projects that will benefit the San Pablo especially the Indigenous people;

WHEREAS, the DOH deploys a Rural Health Physician (RHP), by the name of **DR. JOAN MAE C. BUGAY** who agrees to serve in San Pablo, Zamboanga del Sur and the LGU is willing to accept the same;

WHEREFORE, on motion by Hon. Artemio C. Dayondon, severally seconded, be it
