## **RESOLUTION NO. 2025-146**

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE IX FOR THE IMPLEMENTATION OF SUPPLEMENTAL FEEDING PROGRAM (15<sup>TH</sup> CYCLE) OF SAN PABLO, ZAMBOANGA DEL SUR."

**WHEREAS**, the Local Government Unit recognizes the importance of proper nutrition and aims to address malnutrition and hunger among children in the community;

**WHEREAS**, the Department of Social Welfare and Development (DSWD) plays a pivotal role in implementing programs that alleviate poverty and improve the welfare of vulnerable sectors of society, including children;

**WHEREAS**, the Supplemental Feeding Program established and managed by the DSWD, specifically targets undernourished children in identified areas, providing them with nutritious meals to enhance their well-being;

**WHEREAS**, collaboration between the Local Government Unit and the **DSWD** through a Memorandum of Agreement **(MOA)** will enable the effective implementation of the Supplemental Feeding Program and ensure its sustainability;

**WHEREAS**, entering into **MOA** will establish a cooperative partnership, clarifying the roles, responsibilities, and obligations of both parties involved.

**WHEREFORE**, on motion by Hon. Jorge R. Gonzales, severally seconded, be it

RESOLVED, as it is hereby resolved, AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE IX FOR THE IMPLEMENTATION OF SUPPLEMENTAL FEEDING PROGRAM (15<sup>TH</sup> CYCLE) OF SAN PABLO, ZAMBOANGA DEL SUR.

**RESOLVED FURTHER,** that the memorandum of Agreement shall include the following provisions:

- That the Local Government Unit and the DSWD shall submit a project proposal and master list of beneficiaries as the basis for funding allocation for the 15<sup>th</sup> cycle (CY 2025) and the conduct of twice-a-day feeding provision, if necessary, for the beneficiaries. The mode of the implementation they will use based on the SFP implementing guidelines;
- The MSWDO as the focal person shall be responsible in providing Administrative and Technical Assistance in the operationalization of the SFP and in overseeing the organization of Parents Committee in the assigned barangay.
- 3. The Local Government Unit commits to provide the necessary facilities, equipment and manpower to support the efficient implementation of the program.
- 4. Both the parties shall undertake joint monitoring and evaluation activities to determine he program's success and identify areas for improvement.
- 5. The DSWD shall coordinate in securing the necessary budgetary allocation and resources to ensure the sustainability of the program.

**RESOLVED FINALLY,** that the Local Chief Executive is hereby directed to ensure the prompt signing and effective implementation of the Memorandum of Agreement with the Department of Social Welfare and Development (DSWD) to initiate the implementation of the Supplemental Feeding Program in the municipality of San Pablo, Zamboanga del Sur.
