RESOLUTION NO. 2025-153

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF UNDERSTANDING BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, REGION IX FOR SOCIAL PENSION FOR INDIGENT SENIOR CITIZEN PROGRAM."

WHEREAS, Chapter II, Section 17 (b) (2) (iv) of RA 7160 mandated the municipality/city to provide Social Welfare Services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly and disabled persons; community-based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents, and victims of drug abuse; livelihood and other pro-poor projects; nutrition services; and family planning services;

WHEREAS, the Social Pension of Indigent Senior Citizens (SPISC) program implemented by the Department of Social Welfare and Development (DSWD), provides a **monthly stipend of One Thousand Pesos (P1,000.00)** to qualifying indigent senior citizens to improve their well-being and address their daily subsistence and medical needs;

WHEREAS, DSWD as the lead agency in social welfare and development, has implemented the Social Pension for Indigent Senior Citizens (SPISC) since 2011 through DSWD Field Offices (FOs) in all regions.

WHEREFORE, on motion of Hon. Jonathan B. Medico, severally seconded, be it

RESOLVED, AS IT IS HEREBY RESOLVED, AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF UNDERSTANDING BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, REGION IX FOR SOCIAL PENSION FOR INDIGENT SENIOR CITIZEN PROGRAM.
