RESOLUTION NO. 2025-22

"A RESOLUTION RECOGNIZING THE ALYANSA NG MGA LIDER NG MORO NG ZAMBOANGA DEL SUR (SAN PABLO CHAPTER), SAN PABLO COACHES AND TEAM MANAGER ASSOCIATION AND TICALA FISHERFOLKS ASSOCIATION AS MEMBER OF THE CIVIL SOCIETY ORGANIZATION (CSO) IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."
