**RESOLUTION NO. 2025-35**

**"A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. DIVINE NELEH A. TAUCAN-ANGHAD OF SAN PABLO, ZAMBOANGA DEL SUR TO ENTER INTO AND SIGN THE AMENDED MEMORANDUM OF AGREEMENT (MOA) WITH THE LAND BANK OF THE PHILIPPINES (LBP) – PAGADIAN CITY BRANCH."**

**WHEREAS**, the municipality of San Pablo, Zamboanga del Sur, previously entered into a Memorandum of Agreement (MOA) with the Land Bank of the Philippines (LBP) for the implementation of the Salary Loan Facility (SLF) for Municipal Officials and Employees;

**WHEREAS**, Executive Order No. 12, series of 2024, issued by the Office of the President, prescribes the revised guidelines on the implementation of the Salary Loan Facility to ensure uniformity, transparency, and compliance with updated government policies;

**WHEREAS**, the Land Bank of the Philippines requires the execution of an amended MOA by the concerned Local Government Units (LGUs) to align with the provisions of the said Executive Order;

**WHEREAS**, the Sangguniang Bayan deems it necessary and appropriate to authorize the Local Chief Executive (LCE) to enter into and sign, on behalf of the municipality, the amendment of the MOA with the Land Bank of the Philippines (LBP).

**WHEREFORE**, on motion by Hon. Ronald M. Taganos, severally seconded, be it
