**RESOLUTION NO. 2025-36**

**"A RESOLUTION AUTHORIZING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), 2<sup>ND</sup> ENGINEERING DISTRICT, GUIPOS, ZAMBOANGA DEL SUR, AND/OR ZMS CONSTRUCTION AND DEVELOPMENT CORPORATION, PAGADIAN CITY, TO SECURE A CUTTING PERMIT FROM PHILIPPINE COCONUT AUTHORITY (PCA) FOR SEVEN (7) STANDING COCONUT TREES, SITUATED AT LOT NO. 3239-B, SITUATED AT PUROK TANGKE, POBLACION, SAN PABLO, ZAMBOANGA DEL SUR, COVERED BY TAX DECLARATION NO. 23-20-0001-00022, OWNED BY MUNICIPAL LOCAL GOVERNMENT UNIT OF SAN PABLO, ZAMBOANGA DEL SUR BY VIRTUE OF A DEED OF SALE EXECUTED BY THE ORIGINAL OWNER, ROBERTO PROVIDENCIA IN FAVOR OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR, AS EVIDENCED BY A COPY OF THE DEED OF SALE AND TAX DECLARATION NO. 23-20-0001-00022 WHICH ARE BOTH HERETO ATTACHED."**

**WHEREAS;** during the Regular Session of this august Body, Officials of the DPWH, and Personnel from ZMS Construction and Development Corporation personally appeared and requested for the passage of a resolution authorizing the DPWH and/or ZMS Construction and Development Corporation to secure a cutting permit from Philippine Coconut Authority (PCA) for the cutting of Seven (7) standing coconut trees, located on the land owned by the Municipal Local Government Unit of San Pablo, Zamboanga del Sur;

**WHEREAS,** the said request is in relation to the construction of a SABO Dam wherein those coconut trees are found to be cut in order to implement the said project;

**WHEREAS,** this August Body finds the request to be in order and well-taken.
