## **RESOLUTION NO. 2025-42**

"A RESOLUTION RECOGNIZING THE SAN PABLO MINISTERIAL ASSOCIATION AS MEMBER OF THE CIVIL SOCIETY ORGANIZATION (CSO) IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, the Local Government Unit (LGU) of San Pablo, Zamboanga del Sur upholds the active participation of Civil Society Organizations (CSOs) in local governance, development planning, and decision-making processes;

**WHEREAS**, on July 14, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representative to the Local Special Bodies;

WHEREAS, upon evaluation, the SAN PABLO MINISTERIAL ASSOCIATION, thru the President, Gee-Ann C. Panaligan of Tandubuay, San Pablo, Zamboanga del Sur, has not complied with all documentary requirements prescribed under the relevant guidelines for CSO accreditation.

WHEREFORE, on motion of Hon. Dennis P. Cordero, severally seconded, be it

RESOLVED, as it is hereby resolved, RECOGNIZING THE SAN PABLO MINISTERIAL ASSOCIATION AS MEMBER OF THE CIVIL SOCIETY ORGANIZATION (CSO) IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR.

RESOLVED FURTHER, that this recognition is effective only until June 30, 2028.

**RESOLVED FURTHERMORE,** that copies of this resolution be furnished to the Hon. Municipal Mayor, Divine Neleh A. Taucan-Anghad, the respective President of the above-mentioned organizations, and the DILG Officer, San Pablo, Zamboanga del Sur, for their information and guidance.
