RESOLUTION NO. 2025-46

"A RESOLUTION ACKNOWLEDGING AND AFFIRMING THE OWNERSHIP AND UTILIZATION OF MOTORIZED PUMPBOATS UNDER THE LOCAL GOVERNMENT UNIT (LGU) OF SAN PABLO, ZAMBOANGA DEL SUR FOR PURPOSES OF PEACEKEEPING, ANTI-ILLEGAL FISHING, ANTI-PIRACY, AND ANTI-TERRORISM OPERATIONS."

WHEREAS, pursuant to Sections 16 and 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, local government units are empowered to exercise such powers as are essential to the promotion of the general welfare and to take any necessary action for the efficient and effective governance, including the acquisition and operation of property and equipment in support of peace and order, environmental protection, and public safety;

WHEREAS, the Local Government Unit (LGU) of San Pablo owns and operates several motorized pumpboats used for law enforcement support, peacekeeping, and environmental protection within its territorial waters, namely:

1. **Office of the Municipal Mayor** – Made of wood/lumber, powered by Canter 4DR5-diesel;
2. **Bantay Dagat I** – Made of fiber, powered by Mega Honda 16 H.P.-gasoline;
3. **Bantay Dagat II** – Made of wood/lumber, powered by Mega Honda 16 H.P.-gasoline;
4. **Rebi Beach Resort** – Made of wood/lumber, powered by Mega Honda 16 H.P.-gasoline; and
5. **Jungle Warrior** – Made of wood & fiber, powered by Kama 16 H.P.-diesel;

WHEREAS, the said motorized pumpboats are utilized by the Philippine National Police (PNP) San Pablo Municipal Police Station, the San Pablo Bantay Dagat Task Force, and the Philippine Army-CAFU Unit Detachment stationed within the municipality for peacekeeping, anti-illegal fishing, anti-piracy, and anti-terrorism operations, and it is therefore fitting for the Sangguniang Bayan to formally acknowledge and affirm their ownership and utilization as part of the municipality's assets devoted to public service, law enforcement, and the protection of marine resources;

NOW, THEREFORE, on motion of Hon. Andres M. Villanueva, III severally seconded, be it,

RESOLVED, as it hereby resolved, **ACKNOWLEDGING AND AFFIRMING THE OWNERSHIP AND UTILIZATION OF MOTORIZED PUMPBOATS UNDER THE LOCAL GOVERNMENT UNIT (LGU) OF SAN PABLO, ZAMBOANGA DEL SUR FOR PURPOSES OF PEACEKEEPING, ANTI-ILLEGAL FISHING, ANTI-PIRACY, AND ANTI-TERRORISM OPERATIONS.**
