## **RESOLUTION NO. 2025-48**

"A RESOLUTION DECLARING THE MULTI-PURPOSE BUILDING, WHERE THE EXISTING OFFICES OF THE VICE MAYOR AND THE SESSION HALL ARE SITUATED, AS THE OFFICIAL LEGISLATIVE BUILDING OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR WHERE THE OFFICES OF THE VICE MAYOR, SANGGUNIANG BAYAN MEMBERS, SESSION HALL, AND THE OFFICE OF THE SECRETARY TO THE SANGGUNIANG BAYAN SHALL HEREAFTER BE LOCATED"

WHEREAS, the Multi-Purpose Building presently houses the Office of the Vice Mayor and serves as the official venue of the Sangguniang Bayan's regular and special sessions;

**WHEREAS**, the said building has adequate space and facilities suitable for the establishment of the offices of the Sangguniang Bayan Members and the Secretary to the Sangguniang Bayan;

**WHEREAS**, the consolidation of all legislative offices in one building will promote administrative efficiency, coordination, and accessibility of public service;

**NOW, THEREFORE**, on motion of <u>Hon. Andres M. Villanueva, III</u>, duly seconded by <u>Hon. Joefel G. Medico</u>,

**BE IT RESOLVED**, as it is hereby resolved, to declare the Multi-Purpose Building, where the existing offices of the Vice Mayor and Session Hall are situated, as the official Legislative Building of the Municipality of San Pablo, Zamboanga del Sur, where the offices of the Vice Mayor, Sangguniang Bayan Members, Session Hall, and the Secretary to the Sangguniang Bayan shall officially hold office.

**RESOLVED FURTHER**, that copies of this Resolution be furnished to the Office of the Mayor, the Municipal Engineer, Municipal Planning and Development Coordinator and other concerned offices for their information and appropriate action.
