**RESOLUTION NO. 2025-50**

**"A RESOLUTION ADOPTING THE GAD PLAN AND BUDGET FOR FY 2026 OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."**

**WHEREAS**, the Annual Gender and Development (GAD) Plan and budget of the municipality of San Pablo for FY 2026 was submitted for adoption by the Sangguniang Bayan;

**WHEREAS**, the total amount **Ten Million Four Hundred Sixty-Two Thousand Six Hundred Ninety-Six Pesos and Thirty-One Centavos (P10,462,696.31)**, representing total estimated budget of the LGU for 2026, was properly distributed as follows:


