RESOLUTION NO. 2025-52

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE DIVINE NELEH A. TAUCAN-ANGHAD TO ENTER AND SIGN, ON BEHALF OF THE MUNICIPALITY OF SAN PABLO, A MEMORANDUM OF AGREEMENT FOR THE IMPLEMENTATION OF "WALANG GUTOM 2027: FOOD STAMP PROGRAM" WITH THE REGIONAL DIRECTOR, RIDUAN P. HADJIMUDDIN, CESO III, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, REGIONAL OFFICE IX, PAGADIAN CITY"

WHEREAS, the Department of Social Welfare and Development (DSWD) launched the "WALANG GUTOM 2027 PROGRAM", a flagship anti-hunger initiative of the National Government aimed at ensuring food security and nutritional sufficiency among poor and vulnerable families;

WHEREAS, the program provides food access and livelihood assistance through digital food stamps and partnerships with Local Government Units, consistent with the objectives of Republic Act No. 11310 or the Pantawid Pamilyang Pilipino Program (4Ps) and the Philippine Development Plan 2023-2028;

WHEREAS, the DSWD requires the participation and cooperation of Local Government Units (LGUs) to effectively implement the program at community level, ensuring beneficiary identification, coordination, and monitoring;

WHEREAS, it is deemed necessary and proper for the Municipality of San Pablo to partner with the DSWD for the effective implementation of the "WALANG GUTOM 2027 PROGRAM", in order to alleviate hunger and improve food access among the most vulnerable households in the locality;

NOW, THEREFORE, on motion of Hon. Dennis P. Cordero,
duly seconded by Hon. Amer A. Yap,

BE IT RESOLVED, as it is hereby resolved, to authorize the
Municipal Mayor, Honorable Divine Neleh A. Taucan-Anghad to
enter and sign, on behalf of the Municipality of San Pablo, a
memorandum of agreement for the implementation of "Walang
Gutom 2027: Food Stamp Program" with the Regional Director,
Riduan P. Hadjimuddin, CESO III, Department of Social Welfare
and Development, Regional Office IX, Pagadian City"
