RESOLUTION NO. 2025-56

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DIVINE NELEH TAUCAN-ANGHAD TO ENTER INTO AGREEMENT WITH ZAMBOANGA DEL SUR ELECTRIC COOPERATIVE-I (ZAMSURECO-I) FOR THE PROPOSED VEE-PHASE PRIMARY LINE RELOCATION PROJECT AT SITIO LAYAWAN, BARANGAY PAYAG, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, there is an on-going infrastructure and beautification initiatives of the municipality of San Pablo, Zamboanga del Sur, particularly the construction of **Comprehensive Welcome Arch**, located at Sitio Layawan, Barangay Payag, San Pablo, /Zamboanga del Sur;

WHEREAS, an unexpected challenge was encountered during its implementation which is the affectation of one (1) electric post of ZAMSURECO-I that needs to be relocated so the said project will proceed in accordance with the plan;

WHEREAS, The LGU San Pablo allocated funds for the proposed VEE-Phase Primary Line Relocation Project which shall later be donated to the ZAMSURECO-I for continued maintenance;

WHEREAS, it is deemed necessary to authorize the Honorable Municipal Mayor to enter and sign the agreement with the ZAMSURECO-I to formalize the collaboration and implementation of the project.

WHEREFORE, on motion by Hon. Danilo A. Taucan, severally seconded, be it

RESOLVED, as it is hereby resolved, **AUTHORIZING THE MUNICIPAL MAYOR, HON.
