RESOLUTION NO. 2025-63

"A RESOLUTION RATIFYING THE APPOINTMENT OF MRS. MARYGOLD A. AGUILAR AS OFFICE OF THE SENIOR CITIZEN (OSCA) HEAD OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, Republic Act No. 9994, otherwise known as the "Expanded Senior Citizens Act of 2010," every municipality shall establish an office for the Senior Citizens Affairs (OSCA) to be headed by a qualified Senior Citizen appointed by the Local Chief Executive;

WHEREAS, the OSCA is mandated to plan, implement and monitor programs and activities for the promotion and protection of the rights and welfare of the Senior Citizen;

WHEREAS, the Honorable Municipal Mayor, Divine Neleh Taucan-Anghad of San Pablo, Zamboanga del Sur, has appointed Mrs. Marygold A. Aguilar as the Head of the Office of the Senior Citizen Affairs (OSCA) for her proven integrity, leadership, and dedicated service to the community;

WHEREAS, the Sangguniang Bayan recognizes and supports this appointment, acknowledging Mrs. Marygold A. Aguilar's capacity and commitment to effectively perform the duties and responsibilities of the said office.
