**EXCERPT FROM THE MINUTES OF THE 69<sup>TH</sup> REGULAR SESSION OF THE 10<sup>TH</sup> MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON JULY 28, 2021.**

**RESOLUTION NO 24-0721**

**"A RESOLUTION ADOPTING GAD FOCAL POINT SYSTEM COUNCIL RESOLUTION NO. 1-2021, RE: A RESOLUTION TRANSFERRING THE APPROPRIATION FOR SCHOLARSHIP PROGRAM FOR EARLY TEENAGE PREGNANT STUDENTS AMOUNTING TWO HUNDRED THOUSAND PESOS (P 200,000.00); HATUD SERBISYO PARA SA KABABAINHAN SA KABARANGAYAN AMOUNTING TWO HUNDRED THOUSAND PESOS (200,000.00) AND CAPABILITY BUILDING FOR GFPS AMOUNTING THREE HUNDRED THOUSAND PESOS (300,000.00) TO ASSISTANCE TO CONFIRMED CASES OF COVID-19 (FOOD PACKS) DURING COVID-19 PANDEMIC".**

**WHEREAS**, due the declaration of state of Public Health Emergency throughout the Philippines, all LGU's are enjoined to appropriate disaster response aid and measure to curtail and eliminate the threat of COVID-19;

**WHEREAS**, GAD Focal Point System Council transferred some items in the 2021 GAD Plan and Budget for assistance to confirmed cases of COVID 19 in the municipality of San Pablo, Zamboanga del Sur.

**WHEREFORE**, on motion by Hon. Erlinda P. Castillo, severally seconded, be it

**RESOLVED**, as it is hereby resolved, Adopting Gad Focal Point System Council Resolution No. 1-2021, Re: A Resolution Transferring the Appropriation for Scholarship Program for Early Teenage Pregnant Students amounting Two Hundred Thousand Pesos (P 200,000.00); Hatud Serbisyo Para sa Kababainhan sa Kabarangayan amounting Two Hundred Thousand Pesos (200,000.00) and Capability Building for GFPS amounting Three Hundred Thousand Pesos (300,000.00) to Assistance to Confirmed Cases of Covid-19 (Food Packs) during Covid-19 Pandemic".
