RESOLUTION NO. 271032

"A RESOLUTION AUTHORIZING HON. MUNICIPAL MAYOR BELMAN B.
MANTOS AND MUNICIPAL TREASURER MRS. MARIA ALICIA C.
PROVIDENCIA TO OPEN A TRUST FUND ACCOUNT AT LAND BANK OF
THE PHILIPPINES, PAGADIAN CITY BRANCH OFFICE, PAGADIAN CITY".

WHEREAS, the Department of Agriculture Regional Field Unit IX
(DA-RFU IX) is extending financial assistance to finance agricultural
projects in the municipality of San Pablo;

WHEREAS, the DA-RFU IX has required the LGU San Pablo to open a
Trust Fund Account with LBP, Pagadian City as stipulated in the
Memorandum of Agreement (MOA);

WHEREAS, the Agricultural projects to be implemented as of this
date with LGU counterparting are the following:

- a. Farm to Market Roads Rehabilitation from Sagasan to Sacbulan
(P1 million DA-RFU IX Zamboanga Peninsula Integrated
Agricultural Development Fund (ZIADP)- P120,000.00 LGU San
Pablo counterpart)
- b. Payag Small Water Impounding Project (SWIP) Rehabilitation
(P730,000.00 DA-RFU IX Support to Emergency Livelihood
Assistance Program Fund (SELAP) - P87,000.00 LGU San Pablo
counterpart)
- c. Farm Input Assistance Project (FIAP) at Culasian
(P90,000.00 DA-RFU (SELAP) Fund - P10,000.00 Counterpart fund
is charged to labor cost of Farmer-Recipients)


WHEREFORE, on motion by Hon. Jorge R. Gonzales, severally
