RESOLUTION NO. 27114

"A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 14, 16, 18, 20 AND 27 OF BARANGAY MIASIN, SAN PABLO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration, Barangay Ordinance No. 14, 16, 18, 20, and 27 of Miasin, San Pablo, Zamboanga del Sur;

WHEREAS, the Body has found the said ordinances in order.

WHEREFORE, on motion by Hon. Jorge R. Gonzales, severally seconded, be it

RESOLVED, to approve, as it is hereby approved, Barangay Ordinances of Miasin, San Pablo, Zamboanga del Sur to wit:

1. Ordinance No. 14 - "Ang Ordinansa nga nagdili sa pagbuhi ug kahayupan sulod sa Barangay Miasin;
2. Ordinance No. 16 - An Ordinance prohibiting Public Disturbance during Market day, Parian, benefit Dance or Disco, Video Houses and any other place at Barangay Miasin, San Pablo, Zambo. Sur;
3. Ordinance No. 18 - Ang Ordinansa nga nagsilot sa mga tawo nga naghimo ug kadaut o pagpanamastamas sa pag connect sa mainline sa tubig sa water system project level I sa Barangay Miasin, San Pablo, Zamboanga del Sur;
4. Ordinance No. 20 - Ang ordinansa nga nagpatuman sa pagkolekta sa matag usa nga mo charge ug cellphone sa bisan asa nga outlet nga gipanag-iya sa Barangay;
5. Ordinance No. 27 - An Ordinance imposing business taxes to the residents of Miasin, San Pablo, Zambo. Sur who engage & operate Business like Dealer, Buyer of Large Cattle, etc. .
