EXCERPT FROM THE MINUTES OF THE 15TH REGULAR SESSION OF THE 6TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON DECEMBER 26, 2007.

RESOLUTION NO. 271261

WHEREAS, we recognized previous actions taken by your office in relation to the SB resolutions submitted by LGU San Pablo, requesting the transfer of our Municipal Treasurer, Mrs. Alicia C. Providencia by sending panel of investigation headed by the late Pio K. Morados, Assistant Regional Director;

WHEREAS, as of this moment, we do not receive any official information as to whether or not our request is granted;

WHEREAS, just recently, a Demand Letter was issued by Mrs. Virginia A. Cabilatasan, State Auditor III, COA, Local Government Section, Mindanao Sub-cluster I, Team I, Province of Zamboanga del Sur, Pagadian City against our Municipal Treasurer involving the amount of Four Hundred Thirteen Thousand Eighty Nine Pesos and Sixty Four Centavos (P413,089.64);

WHEREAS, we are determine to pursue good governance through a very sound fiscal management and we believe we can't do so unless our treasurer be transferred/replaced;

WHEREAS, we strongly recommend Mrs. Lilia T. Paloma, Local Revenue Collection Officer II, to be designated as the OIC in the office of the Treasurer of San Pablo, Zamboanga del Sur, should our request be given preferential attention.

WHEREFORE, on motion, severally seconded be it

RESOLVED, AS IT IS HEREBY RESOLVED, REQUESTING MR. TALIB A. TAPSI, ICO REGIONAL DIRECTOR, BUREAU OF LOCAL GOVERNMENT FINANCE, DEPARTMENT OF FINANCE, REGION IX, ZAMBOANGA CITY FOR THE IMMEDIATE TRANSFER OF MRS. MARIA ALICIA C. PROVIDENCIA, MUNICIPAL TREASURER OF SAN PABLO, ZAMBOANGA DEL SUR.




