WHEREAS, request for appropriation dated June 18, 2008 was submitted to defray Other maintenance and Operating expenses of the Doctor to the Barrios; the Chief of Police; the MLGOO and salary step increment of Mr. Ebenezer Mantos.

APPROPRIATION ORDINANCE NO. 07-0728

Section 2. The total amount of One Hundred Fifty Seven Thousand One Hundred Five pesos (P157,105.00) as PS savings from the position of Municipal Health Officer, San Pablo, Zamboanga del Sur is hereby properly appropriated as follows:

1. Doctors to the Barrio (Other Maintenance & Operating Expenses)	P119,040.00
2. Chief of Police (Other Maintenance & Operating Expenses)	14,400.00
3. MLGOO (Other Maintenance & Operating Expenses)	14,400.00
4. Sal. Step Increment of Mr. Ebenezer Mantos (July 16 to Dec. 31, 2007) and (January 1 to December 31, 2008)	<u>8,631.88</u>
Total	P 156,471.88

Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws and regulations enforce.
