ABEL JAGMOC GERONA, PRESIDENT/CEO OF WIZARD BLUE AMBASSADORS MANAGEMENT CONSULTANCY SERVICES AND WIZARD BLUE AMBASSADORS CORPORATION, 7TH FLOOR, GLORIETTA 4, AYALA CENTER, MAKATI CITY TO ALLOCATE FUNDS AMOUNTING THIRTY MILLION PESOS (P30,000,000.00) FOR THE INSTALLATION OF SOLAR LIGHTS FROM REBI RESORT, REBI, TENIAPAN, SAN PABLO, ZAMBOANGA DEL SUR TO POBLACION, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, the municipality of San Pablo, Zamboanga del Sur is a fourth class municipality where majority of the people greatly depends on farming and fishing as their means of living;

WHEREAS, the opening of the LGU owned Beach Resort generated additional income from local sources;

WHEREAS, coastal roads connecting the municipality of Tabina - San Pablo – Pagadian City is soon to be finished, which means many visitors/holidaymakers and investors are coming to our place for a vacation or investment;

WHEREAS, as of this time, no Street lights are being installed to the newly concreted coastal roads even at San Pablo municipality since the LGU has no capacity to install due to the scarcity of local budget;
