RESOLUTION NO. 2906047

"A RESOLUTION CONCURRING THE APPOINTMENT OF DR. HERMERALDO M. CATUBIG AS MUNICIPAL HEALTH OFFICER OF SAN PABLO, ZAMBOANGA DEL SUR EFFECTIVE MAY 16, 2009".

WHEREAS, the Municipality of San Pablo has no permanent health Officer to take charge at the Municipal health Office due to the resignation of the regular Municipal Health Officer (MHO) ;whereby only a Doctors to the Barrio is present in the person of Dr. Hermeraldo H. Catubig Jr.

WHEREAS, his term of office as Doctor to the Barrio ended last May 15, 2009;

WHEREAS, the body has found the necessity of his position now that the department of Health have launched and implemented many programs of the Government concerning health services for the people;

WHEREAS, the appointment for the Municipal Health officer with a salary Grade 24 was issued to Dr. Hermeraldo M. Catubig, Jr. effective May 16, 2009.

WHEREFORE, on motion by Hon. Jorge R. Gonzales duly seconded by Hon Jonathan B. Medico be it.

RESOLVED, as it is hereby resolved, concerning the appointment of Dr. Hermeraldo M. Catubig Jr as the Municipal health Officer of San Pablo, Zamboanga del Sur effective May 16, 2009.






