A RESOLUTION REQUESTING HER EXCELLENCY GLORIA MACAPAGAL- ARROYO, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, MALACANANG PALACE, MANILA THRU THE HONORABLE EDUARDO ERMITA, EXECUTIVE SECRETARY, OFFICE OF THE PRESIDENT, MALACANANG PALACE MANILA, FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF TWENTY MILLION PESOS (Php 20 M) FOR THE CONSTRUCTION OF DRAINAGE CANAL IN THE URBAN BARANGAYS OF POBLACION AND MARCOS VILLAGE, SAN PABLO, ZAMBOANGA DEL SUR.

Whereas; barangays Poblacion and Marcos Village are adjacent urban barangays and are the center of business activity of the Municipality;

Whereas, flooding has been the perennial problem faced by these barangays which cause inconvenience on the part of the motorist, other transportation vehicles and commuters thereby affecting the flow of goods and services in the area;

Whereas; the LGU is financially constraint to finance for the construction of drainage canal to address this perennial problem;

Now, wherefore, on motion by Honorable Joey R. Gonzales severally seconded, be it

Resolved as it is hereby resolved to request Her Excellency Gloria Macapagal Arroyo, President of the Republic of the Philippines, Malacanang Palace, Manila, for financial assistance in the amount of Twenty Million Pesos (PHP 20 M) for the construction of drainage canal in the urban barangays of Poblacion and Marcos Village, San Pablo, Zamboanga del Sur.

Let copies of this resolution be furnished to the different agencies concerned for information and reference.


