**RESOLUTION NO. 2910073**

" A RESOLUTION GRANTING AUTHORITY TO HONORABLE BELMAN B. MANTOS, MUNICIPAL MAYOR OF SAN PABLO, ZAMBOANGA DEL SUR TO APPLY, SIGN AND OPEN A LETTER OF CREDIT WITH LAND BANK OF THE PHILIPPINES FOR THE PURCHASE OF ONE (1) UNIT BRAND NEW VIBRATORY ROAD ROLLER MODEL SV512D AND PURCHASE OF ONE (1) UNIT BRAND NEW HOLLAND LOADER BACKHOE MODEL B155 AND TO NEGOTIATE, APPLY OR REQUEST FOR TARIFF, TAX AND DUTY FREE IMPORTATION WITH THE DEPARTMENT OF FINANCE AND THE BUREAU OF IMPORT S SERVICES, DEPARTMENT OF TRADE AND INDUSTRY FOR THE IMPORTATION AND PURCHASE OF SAID EQUIPMENT'.

WHEREAS, presented for deliberation of the Sangguniang Bayan was the letter dated October 1, 2009 of Hon. Belman B. Mantos, Municipal Mayor, this Municipality, requesting the passage of a resolution granting authority to Hon. Belman B. Mantos, Municipal Mayor, this Municipality to open a letter of credit with the Land Bank of the Philippines in the amount P16,000,000.00 for the purchase and importation of one (1) unit Brand New VIBRATORY ROAD ROLLER MODEL SV512D and PURCHASE OF ONE (1) UNIT Brand New Holland Loader Backhoe Model B155 as well as to apply for tariff, tax and duty free importation with the Department of Finance and the Bureau of Imports Services, Department of Trade and Industry, Manila;

WHEREAS, the procurement of the aforementioned equipment will be utilized to hasten the construction of various infrastructure projects undertaken by the Municipal Government of San Pablo, Province of Zamboanga del Sur, such as the construction of roads, bridges and other infrastructure project designed to improve socio-economic productivity and spur country side development.


NOW WHEREFORE, after due deliberation, on motion of Hon. Erlinda P. Castillo, duly seconded by Hon. Jorge R. Gonzales, it was,


RESOLVED by the Sangguniang Bayan of San Pablo, Province of Zamboanga del Sur in session assembled granting authority to Hon. Belman B. Mantos, Municipal Mayor of this Municipality to apply, sign and open letter of Credit with the land Bank of the Philippines in the amount of Sixteen Million Pesos (P16,000,000.00) for the purchase of one (1) Unit Brand New Vibratory Road Roller model SV 512D and one (1) Unit Brand New Holland Loader Back Hoe model B115.


RESOLVED FURTHER, to authorize Honorable Municipal Mayor Belman B. Mantos to negotiate, apply or request for tariff, tax and duty free important with the Department of Finance and the Bureau of Imports Services Department of Trade and Industry for the abovementioned equipment.


Let copies of this resolution be furnished to the different agencies concerned for information and ready reference.


