RESOLUTION NO 30-0821

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A. TAUCAN TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH (DOH) – ZAMBOANGA PENINSULA CENTER FOR HEALTH DEVELOPMENT, REPRESENTED BY JOSHUA G. BRILLANTES, MD, MPH, CESE, OIC DIRECTOR IV, FOR THE GRANT OF COVID-19 SPECIAL RISK ALLOWANCE TO ALL ELLIGIBLE PRIVATE AND PUBLIC HEALTH WORKERS OF LGU SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, under Department Order no 0343, the ZP-CHD shall transfer funds in the total amount of One Million Sixty Four Thousand Nine Hundred Eighty Seven Pesos and Twenty Two Centavos (P1,064,987.22) to the municipality of San Pablo, Zamboanga del Sur, to cover the cost of the grant of COVID-19 SRA, chargeable against the Maintenance and other Operating Expenses (MOOE) Quick Response Fund (QRF) under SARO No. SARO-BMB-B20-0022460 dated December 28, 2020 and SARO-BMB-B-210004459 dated June 25, 2021;

WHEREAS, the LGU of San Pablo shall facilitate the payment of COVID-19 SRA to its eligible health workers; submit to the ZP-CHD the final report on the number to eligible health workers assigned by the human resource personnel or personnel division and certified by the head of the facility; as well as any other related guidelines that may be issued by the ZP-CHD.

WHEREAS, in addition thereto, the municipality of San Pablo shall submit liquidation report in accordance with pertinent accounting rules and regulations within Thirty (30) days from termination of this Agreement.

WHEREFORE, on motion by Hon. Artemio C. Dayondon, severally seconded, be it

RESOLVED, as it is hereby resolved, **AUTHORIZING THE MUNICIPAL MAYOR, HON. DANILO A.
