RESOLUTION NO. 78-03-2022

“A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE DANILO A. TAUCAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), AND PROVIDE EQUITY OF AT LEAST 20% OF THE TOTAL PROJECT COST APPROVED BY DOLE REGARDING THE IMPLEMENTATION OF DEPARTMENT OF LABOR AND EMPLOYMENT-TULONG PANGHANAP-BUHAY SA ATING DISPLACED/DISADVANTAGED WORKERS PROGRAM (DOLE-TUPAD) IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR.

WHEREAS, the DOLE and the Municipal Government of San Pablo, Zamboanga del Sur aim to promote employment opportunities for the constituents of the Municipality of San Pablo through an Emergency Employment Assistance Program;

WHEREAS, in line with the above program thrust and policy, the DOLE initiated the Department of Labor and Employment-Tulong Panghanap-buhay sa ating Displaced/Disadvantaged Workers Program or the DOLE-TUPAD Program;

WHEREAS, the Municipality of San Pablo, Zamboanga del Sur have agreed to support the realization of the above-mentioned program for the benefit and interests of its constituents;

WHEREAS, there is a need to authorize the Municipal Mayor, Honorable Danilo A. Taucan to enter with a memorandum of agreement with the DOLE for the implementation of the DOLE-TUPAD Program.


WHEREFORE, premises considered and on motion of Honorable Artemio C. Dayondon, unanimously seconded, be it;



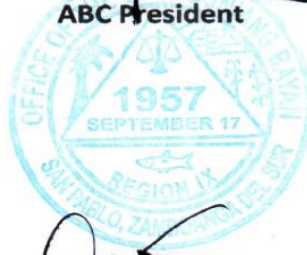
